Comments While drilling the curve on Leonard 5C, we believed our targets were coming in higher than expected so our landing target was raised 30'. After landing and drilling ahead we discovered our original target was correct and we had been out of zone the entire lateral. We believed we could pull back and sidetrack quickly to get in zone and stay there the entire lateral. We sidetracked at 8075' and changed targets to stay in zone.
