Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

5. TIH with tubing to 5120'. RU cementing company. Mix and pump 45 sxs 15.8#/gal CI G cement down tubing to 4527'
6. TIH with tubing to 973'. RU cementing company. Mix and pump 90 sxs 15.8#/gal CI G cement down tubing to surface.
7. Cut surface casing 6' below ground level and weld on cap.
