Inspection doc. #682501807 required operator to remove utilities from the location and perform reclamation. Utilities have been removed. Resolution doc. #401380766 stated location has been reseeded this year. Location appears to remain predominantly undesirable weedy plant species such as Kochia and Salsola sp. Additional monitoring will be required. Continue to monitor and manage location. Once location meets COGCC 1000 series reclamation standards, submit a form 4 stating final reclamation complete and site ready for inspection.
