As stated in Form 19 oil was primarily contained in a man made siphon, which is devoid of vegetation and at a lower grade than the surroundings, thus no re-contouring and reseeding of siphon is necessary. The remainder of the visibly contaminated soil along the spill path was cleaned by hand with a bucket and shovel having minimal impact to vegetation and grade, thus reseeding and regarding is unnecessary.
