The pipeline was shut-in, the point of release area was excavated, the pipeline was repaired and initial samples were collected from the open excavation.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Excavation occurred at the point of release and the pipeline was repaired. While the excavation was open samples were collected from below the point of release and in the down gradient extent of the excavation to a max depth of 15 feet. These initial analysis indicated impacts exceeding table 910-1 for organic and in-organic compounds. The site investigation plan identifies 6 boring locations 3 on the ridge and 3 in the valley. Samples will occur from areas identified in the field as impacted and a sample will be collected from below the impacts as a point of compliance. Depending on depth of impacts a minimum of 2 grab samples will be collected from the soil borings these soils will be analyzed for 910-1 constituents. see attached site diagram.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

A water sample was collected from the permitted water well (20170913- ENPR-5WW) 4500ft down gradient of the spill area. The drilling investigation plan has 3 of the identified soil boring locations as potential monitoring wells if groundwater is encountered.
