Jennifer,

I am returning the sidetrack Form 2 back to draft for the following corrections:

- on the Well Name tab, add the text "unplanned sidetrack" to the "Other" box.
- the attached lease map does not match the originally permitted lease description, which was All Sec 19. Please correct all lease info/attachments. (If lease is the same as originally permitted, and can be described in simple terms, no need for an attachment.)
- delete the SUA attachment, well location plat, and deviated drilling plan; as long as they are the same as in the original permit, there is no need to attach a duplicate.
- attach the required wellbore diagram, showing all casing, plugs, and KOP for the sidetrack wellbore.
- convert Diana Burn's verbal approval email to a PDF and attach it as correspondence (include your engineer's initial email).
- add the Location ID# 450063 to the Submit tab.
- add the Wellbore Integrity Contact Email to the Offset tab.

I have a couple of questions before I resubmit

1. We lost the BHA (not radioactive, not electric). We would prefer to not fish this and drill around the fish – this changes one line of the directional data and I will submit the revised data- The BHA consists of
 - a. 8-3/4" roller cone bit
 - b. Bit sub
 - c. XO
 - d. 1 joint drill pipe
 - e. Reamer
 - f. 1 joint drill pipe
 - g. Reamer
2. I believe I made a mistake with the lease map. The map I submitted was for the SUA. The lease description has not changed. I will correct.
3. For the wellbore diagram, do you want to see the casing as we have it thus far (surface casing only), or the planned casing to be run in the sidetrack?

Jennifer,

Even though the BHL footage is not changing, there are still issues with the total measured depth (TMD) of the sidetrack.

On the APD, you list the TMD at 15644', the same as originally permitted. Since the wellbore has to go around the fish now, the sidetrack TMD should be a little bit different. The wellbore diagrams list TMD at 15692', and the revised deviated drilling plan lists TMD at 15786'.

The TMD should be (more or less) consistent across all similar data fields: Drilling tab, casing tab (setting depth), imported directional data (yellow tab), wellbore diagrams, and deviated drilling plan.

I'm sending the form back to draft for you to correct wherever needed to make sure TMD is consistent. Please also add a comment on the submit tab describing the fish, since that wasn't included in the correspondence with Diana.

On the sidetrack for the Grande (401405988), you have the proposed total measured depth listed at 15692'. The casing tab has setting depth and cement bottom at 15644'. The imported directional data has 15644'. The deviated drilling plan has 15786' (on the bottom of the table on page 6). The wellbore diagrams have 15692'.

All these depths need to be essentially the same number. Please let me know when you've resubmitted this with the necessary corrections; it's been 5 days since this sidetrack occurred and we need to get this permit approved asap. Please call me if you have any questions.
