Comments The location identification footages were provided from the Critter Creek 243-1708H proposed well. The distances for the cultural setbacks were provided from the Critter Creek 541-1708H proposed well. All salable quality gas will be piped to a sales line. No unnecessary or excessive flaring will occur at the subject location. Per rule 316C.c a 48 hour notice will be filed prior to commencement of construction operations with the COGCC via a Form 42. The proposed setback locations for the producing intervals of each wellbore complies with order number 421-79 (Codell) and order number 421-85 (Niobrara). The nearest water well was determined using the COGCC maps and the CDWR permit database. The water well permit number is 9063720 with 22' to ground water. Surface Use Agreement attached for informational purposes.
