Environmental	Originally submitted 1/4/2013 but never processed by COGCC. See attachment for original and data. This was a blowdown pit. Pit ID#101749 was permitted by a prior operator. All samples were Table 910-1 compliant. This pit has been closed in the COGCC database. Based on the information presented, it appears that no further action is necessary at this time and the COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be impacted, then further investigation and/or remediation activities may be required. In addition, the surface area disturbed by the remediation activity shall be reclaimed in accordance with the 1000 Series Reclamation Rules.	09/27/2017
