I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comment.

In the Water Resources section Mallard Exploration has indicated the estimated depth to groundwater is 136 feet. During my review I identified a water well (Permit #292560), that while a little further away to the northeast, has a listed depth to water of 52 feet. I think this depth is more indicative of how shallow groundwater can be in the area of this proposed Oil & Gas Location. Therefore, I would like to change the estimated depth to groundwater from 136 feet to 52 feet.
