Resolution doc. #401380671 stated CA had been addressed. This location does not meet reclamation requirements. Previous inspections identified gravel on location that needed to be removed. Gravel material has not been removed, also a concrete pump base that had not previously been identified appears to have been covered by the gravel. This should also have been removed per reclamation requirements. Original corrective action and corrective action date remains applicable.</p>	
Corrective Action:	<p>Perform reclamation in accordance to COGCC 1000 series reclamation rules and requirements and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of predisturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.</p>	Date 06/10/2016
