Comment: Inspection doc. #682501801 documented insufficient vegetative cover (location has not achieved a total perennial, non-invasive uniform plant cover of at least eighty (80) percent of the surrounding reference), pipe, anchors and gravel remaining on location. No reclamation work has been conducted; pipe, anchors and gravel remains. Original corrective action and corrective action date remains applicable.

Corrective Action:	Perform reclamation in accordance to COGCC 1000 series reclamation rules and requirements. Remove pipe, anchors, gravel and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.	Date	05/31/2017
