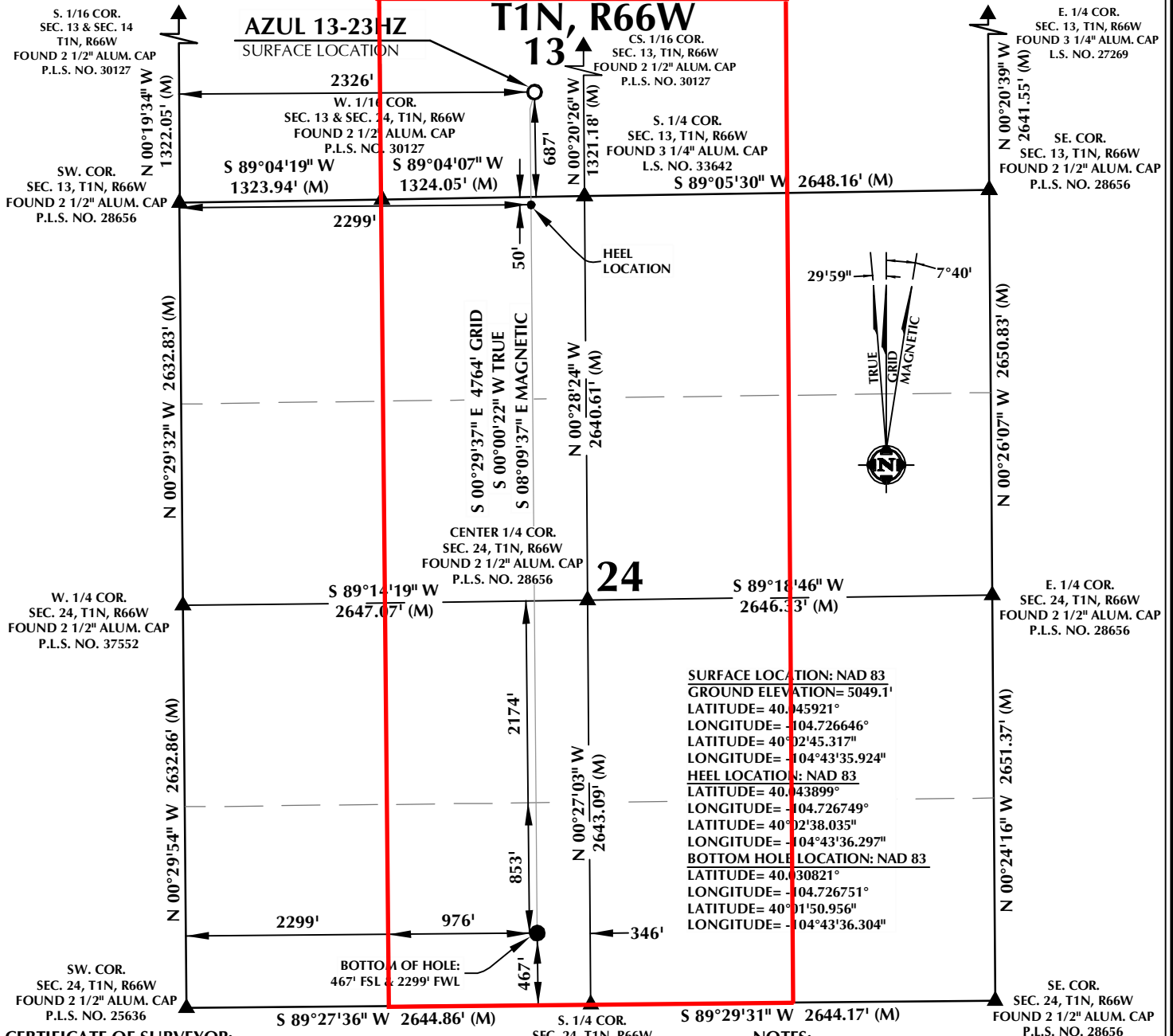

PROPOSED SPACING UNIT



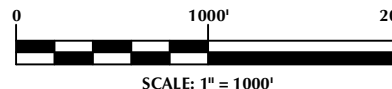

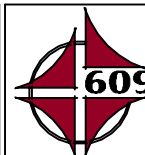
