Dear Mr. Johnson:

The Colorado Oil and Gas Conservation Commission ("COGCC") has adopted guidelines and procedures regarding oil and gas activities affecting the surface. These rules stipulate that an affected surface owner must be given notice in writing by an operator at least thirty (30) days prior to drilling an oil and gas well.

Kerr-McGee Rocky Mountain Corporation ("KMG") intends to begin operations to drill the above captioned oil and gas well(s) upon approval of title, receipt of permits from the COGCC, but prior to January 31, 2004. As the surface owner, it is your responsibility to notify the tenant farmer, if applicable, of this proposed operation.

The COGCC's brochure for surface owners containing the rules pertaining to notice of oil and gas operations, reclamation and opportunities for consultation thereon, as well as, the rules of procedure for filing complaints and making applications for hearings is enclosed.
