Remediation of EC in soil less than 3' bgs in the areas surrounding B4, B5, B6, B7 & B8 will be accomplished by surface application of a calcium soil amendment (gypsum). The proposed remediation schedule calls for soil amendment application during the month of October with attainment of EC & SAR concentrations less than Table 910-1 screening levels in 18 to 24 months verified by soil sample collection and laboratory analysis.

The location will continue to be included in Kinder Morgan's noxious weed prevention program.
