Comments This is a refile, no changes to the well are proposed at this time. The pad has not been built for this location, the Form 2A expires on 9/29/18. If the pad has not been built prior to the Form 2A expiring the Form 2A will be refilled.

First String / Production cement will be > 500 feet above TOG. Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to Ursa's proposed VF G 21C-14-06-92. Distance to the nearest well completed in the same formation / permitted or existing well belonging to another operator was measured at 4405' to Vanguard's Tharp 44D-14-692 (API 05-045-18599).
