Comment: Well was plugged 5/20/2014. The removal of all equipment has been performed. Gravel pile has been removed but gravel remains at the well location. Appears location was mowed, including noxious weeds. Canada thistle rosettes, a List B CO Noxious weed, were observed at location. Location still has to be seeded and compaction alleviation performed. Please refer to the attached inspection photos for more detail.

Corrective Action:	Perform reclamation in accordance to COGCC 1004 series reclamation rules and requirements. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. The Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than November 15, 2017 or sooner depending on favorable environmental conditions.	Date	11/15/2017
