First String / Production cement will be > 500 feet above TOG. Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to Ursa's proposed VF G 24B-14-06-92. Distance to the nearest well completed in the same formation / permitted or existing well belonging to another operator was measured at 2065' to Vanguard's Dixon Federal 11D-23-692 (API # 05-045-21112).
