First String / Production cement will be > 500 feet above TOG. Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to Ursa's proposed VF G 33C-14-06-92. Distance to the nearest well completed in the same formation / permitted or existing well belonging to another operator was measured at 1740' to Vanguard's Tharp 44D-14-692 (API # 05-045-18599).
