A rise in Bradenhead pressure was logged on 09/15/2017 at approximately 08:00 and was subsequently reported (DOC # 401404807). The rise in Bradenhead pressure occurred within a 24 hour time-frame of frac operations taking place on an offset well within 300 ft. Currently, an ongoing investigation is being conducted as to the root cause of the Bradenhead pressure event. Kerr-McGee will follow-up with our findings in 30 days. Thank you.
