RECLAMATION PLANNING

The soil material surrounding the pit (berms) will be pushed into the pit bottom. Backfill material from a local source will be brought to location to bring the pit area to grade after compaction. Compaction will be done with the equipment brought in to backfill the pit. The location itself is fairly flat with a gentle slope to the south, and recontouring of the area will be done to return it to its natural topography.

The location will be seeded with Sharp's Dryland Pasture Mix, which is comprised of wildrye, brome, wheatgrass, orchardgrass, and ryegrass species. The optimal timeframe for seeding is the end of October to mid-November, which will guide Foundation's timeframe in executing the pit reclamation work. Noxious weeds do spring up in this area and will be sprayed by a contractor as necessary. Foundation will make a point to monitor the reclamation progress of this location for the success of the grass seed mix and the presence of weeds.

Foundation has contacted the surface land owner regarding the equipment at the location that belongs to the previous operator. Foundation has received verbal approval to leave the equipment. Reclaimed gravel will be placed on the existing perimeter road.
