### INITIAL ACTION SUMMARY

On July 31, 2014, a field inspection violation was issued by the COGCC (Doc # 667500286) indicating oil saturated soils were present at the Moyer B pit (Facility ID# 100580) location. Approximately 16,00 cubic yards (CY) of impacted sil were removed and stockpiled on location for subsequent treatment and sampling, as described in the Form 27 submitted on June 30, 2014 by Lt Environmental, Inc, (LTE). At the request of the COGCC, groundwater characterization was completed prior to soil treatment to determine if the presence of dissolved phase petroleum hydrocarbon impacts on site.
