Run 4 1/2" casing with turned down collars, set new 4 1/2" casing to immediately above, or as close to, as joint lengths permit, and cement to surface, drill out, run 2 3/8" tubing and packer to approx 5940', then MIT and return to injection status within the allotted 6 months.
