Performed bradenhead test on 9 well pad post production. Initial bradenhead pressure 450 psi had continuous gas for that blew down to a whisper with 5 PSI on the bradenhead after 30 minutes. PDC is requesting a blowdown period and will plumb the bradenhead to a tank for 14 days monitor and re-test. A Bradenhead gas sample will be collected and will be submitted to COGCC as soon as results are available.
