Remove concrete debris. The location, and all areas disturbed due to the removal of said debris will need to be reclaimed; Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. The removal of debris and revegetation activities shall be complete no later than 11/15/2016.
