6. TIH w/ tbg to 5197'KB. Mix and pump 341 sks 15.8#/gal CI G cmt.

7. TOO H to 710'KB. Mix and pump 257 sks 15.8#/gal CI G cmt DH. CMT should circulate to surface.

8. TOO H tbg & top off cmt.

9. Dig down and cut surface csg 6' below GL. Weld cap.
