	Operator shall submit Form 27 Subsequent documenting pit closure within 180 days of pit closure.
	Operator has received COGCC approval to discontinue testing for Arsenic for produced water pit closures. SAR slightly exceeds Table 910-1 limits. Since these pit contents exceed the background concentrations for As, the Operator will need to mix in 30% clean fill material and also must ensure that remaining pit contents are covered with a minimum of 3 feet of backfill and soil. The soil horizons must be replaced in their original relative position, and reclaimed in accordance with 1000 Series Rules.
