Comment: BMP's have adequately been installed and repaired. Culverts were installed to direct stormwater flow away from the access road and highway. Gravel was applied to the road surface and compacted to prevent vehicle tracking. The areas of erosion along the road were filled in with gravel material and some rock rip/rap to prevent erosion. The ditches along the road were cleaned out to direct stormwater flow. The cut slope at the location was hydromulched. See Attached Photos
