280 Acres

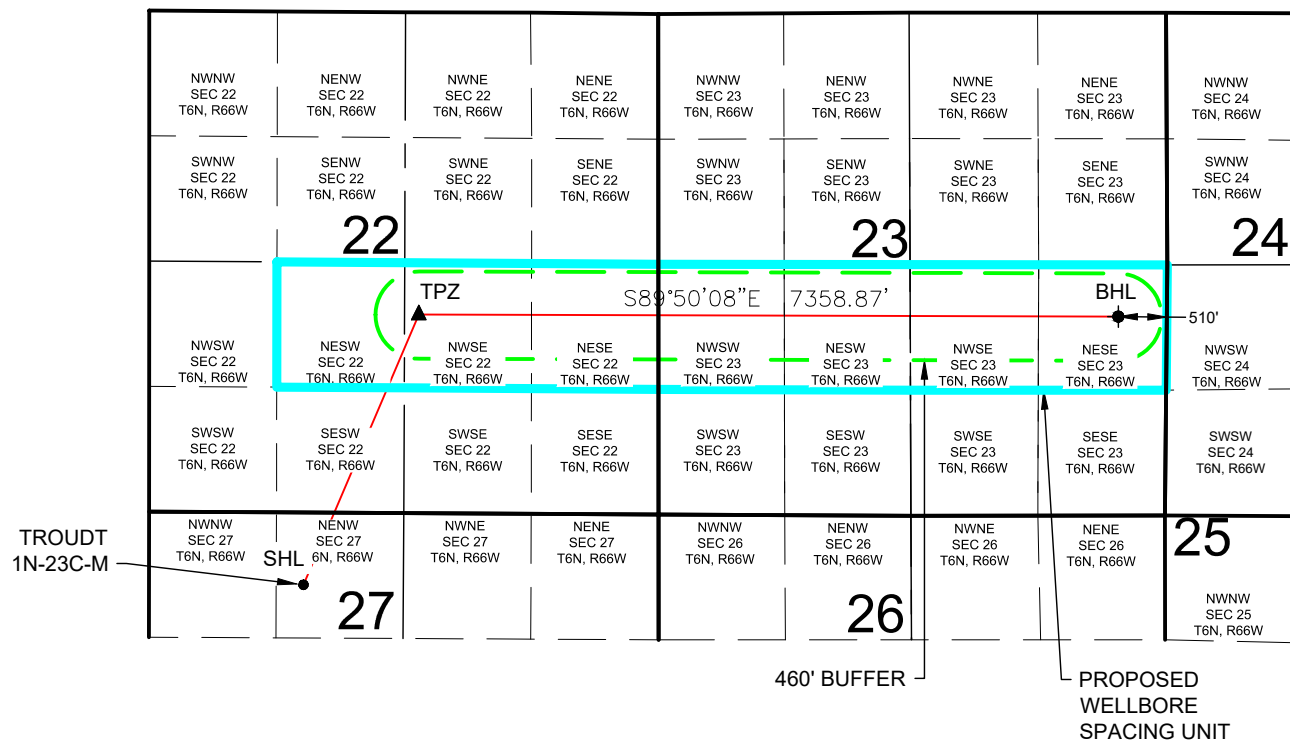
SRC Energy is not the only owner within the proposed wellbore spacing unit and hereby certifies to the Director that a thirty day (30-day) notice has been given by certified mail to all owners in the proposed wellbore spacing unit, as required by COGCC Rule 318A.e. (5). Copies of the required notification letters are on file at SRC Energy's office. The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. We have not received any objections to such well location or proposed spacing unit, therefore, SRC Energy hereby requests the Director approve the well.

TROUDT 1N-23C-M WELLBORE SPACING UNIT

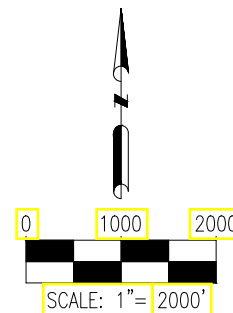


TROUDT 1N-23C-M WELL TO BE LOCATED 760' FNL AND 1624' FWL, SEC 27, T6N, R66W
