560 Acres



The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. # TROUDT 41N-23A-M WELLBORE SPACING UNIT




**TROUDT 41N-23A-M WELL TO BE LOCATED 760' FNL AND 1700' FWL, SEC 27, T6N, R66W**
