280 Acres

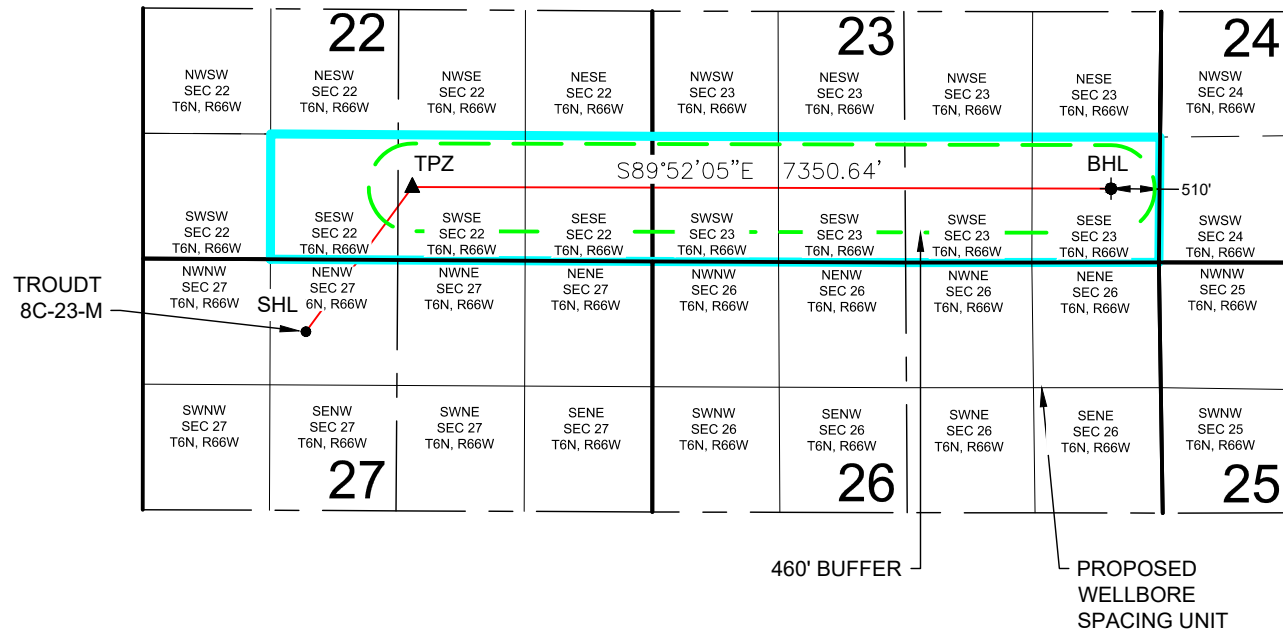

(5). Copies of the required notification letters are on file at SRC Energy's office. The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. TROUDT 8C-23-M WELLBORE SPACING UNIT

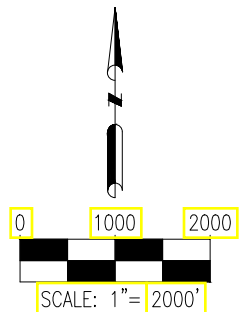


TROUDT 8C-23-M WELL TO BE LOCATED 760' FNL AND 1715' FWL, SEC 27, T6N, R66W
