Hi, Matt,

As you are aware, Bonanza Creek built three locations on the Cervi Ranch surface without an approved Form 2A. Two of these locations have had the Form 2A and related APDs submitted as of Friday and Saturday:

2A#401434231, Mustang U-22 and APD #401433957 in S. 22-4N-63W

2A#401435771, Mustang 12-26 and APD #401435767 in S. 26-4N-63W

Both sets of applications included an expedited request letter citing Rule 303.i.(1) which allows an operator to request expedited approval due to lease expirations that will occur if operations do not commence immediately.

Both sets of applications also included a copy of the required waiver from Troy Swain, Weld County LGD.

The SUA submitted with the applications included language waiving all COGCC required notifications under Rule 305 and 318 with respect to the listed eight wells named in the SUA (refer to page 8). Do you agree with Bonanza Creek that this waiver language provides the surface owner waiver of the 20 day public comment period? Or does Bonanza Creek need to obtain a separate waiver from Mr. Cervi? I have attached a copy of this SUA for your reference.

Please advise if you will grant this request for both locations. COGCC will continue to pursue formal enforcement for all three unapproved, but built locations. A comment summarizing this will be placed on both Form 2As.

Bonanza Creek has been advised not to spud a well for which they do not have an approved APD and to my knowledge has not done so.

Thank you for your consideration and advice. Please let me know if you would like additional information.
