Bonanza Creek has one more location in the NWSW S. 26-4N-63W for which they would like expedited approval in order to keep up with their rig schedule.

This is the Mustang 14-26 location which was originally approved with a surface hole location in a GWA window, but it was moved once the SUA with Mr. Cervi was signed. This SUA provides the surface owner waiver for the public comment period.

Attached are the expedited request letter asking for expedited approval under Rule 303.i.(1) due to lease expiration concerns and the email waiver from the Weld County LGD.

This 2A, document #401440889, has a public comment period expiring on November 23, 2017. Bonanza Creek has asked for expedited approval no later than November 17. The related APD has a sundry in process to move the surface hole location and extend the wellbore to two miles.
