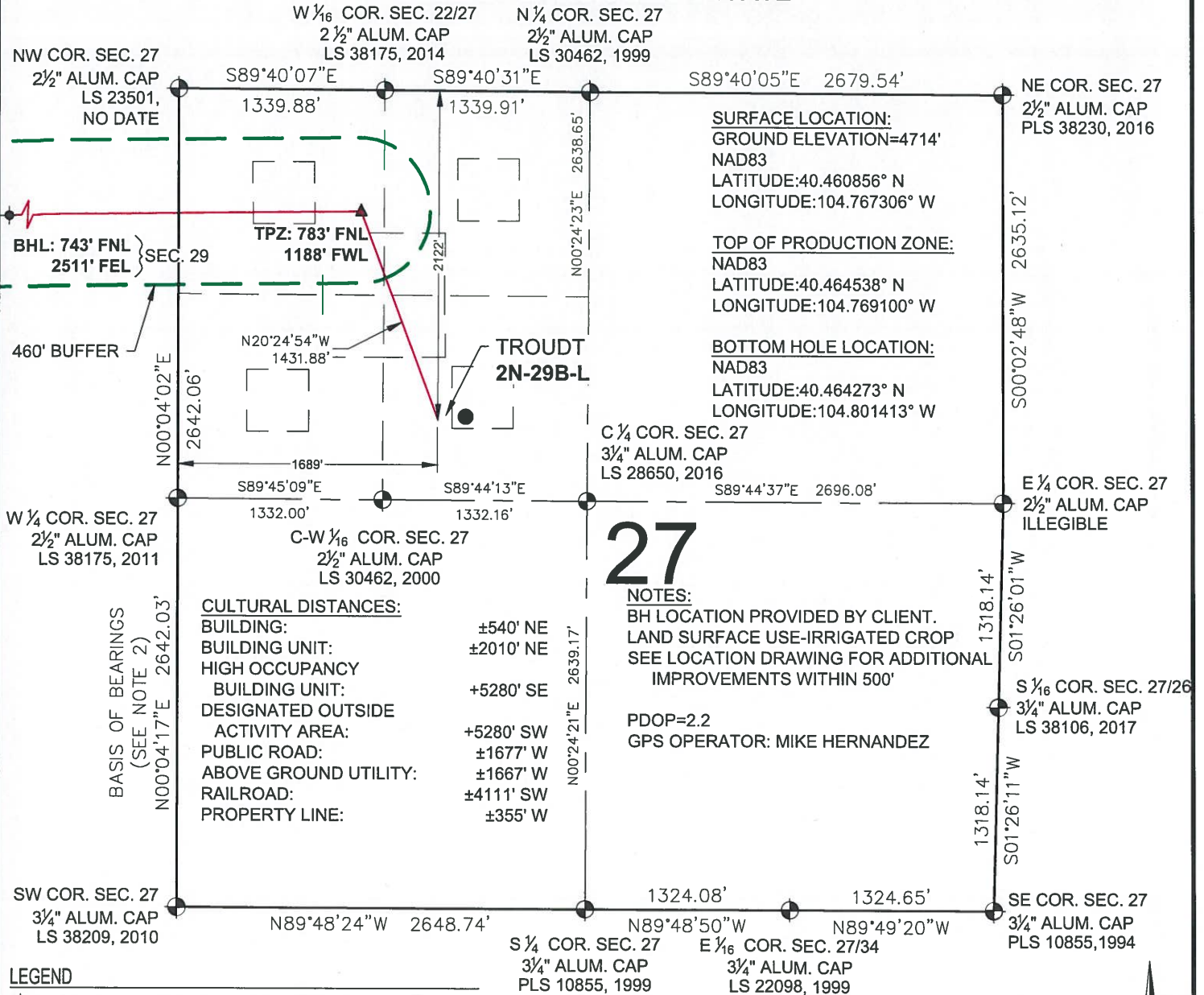


# TROUDT 2N-29B-L WELL LOCATION CERTIFICATE

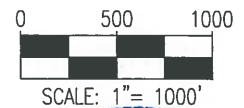
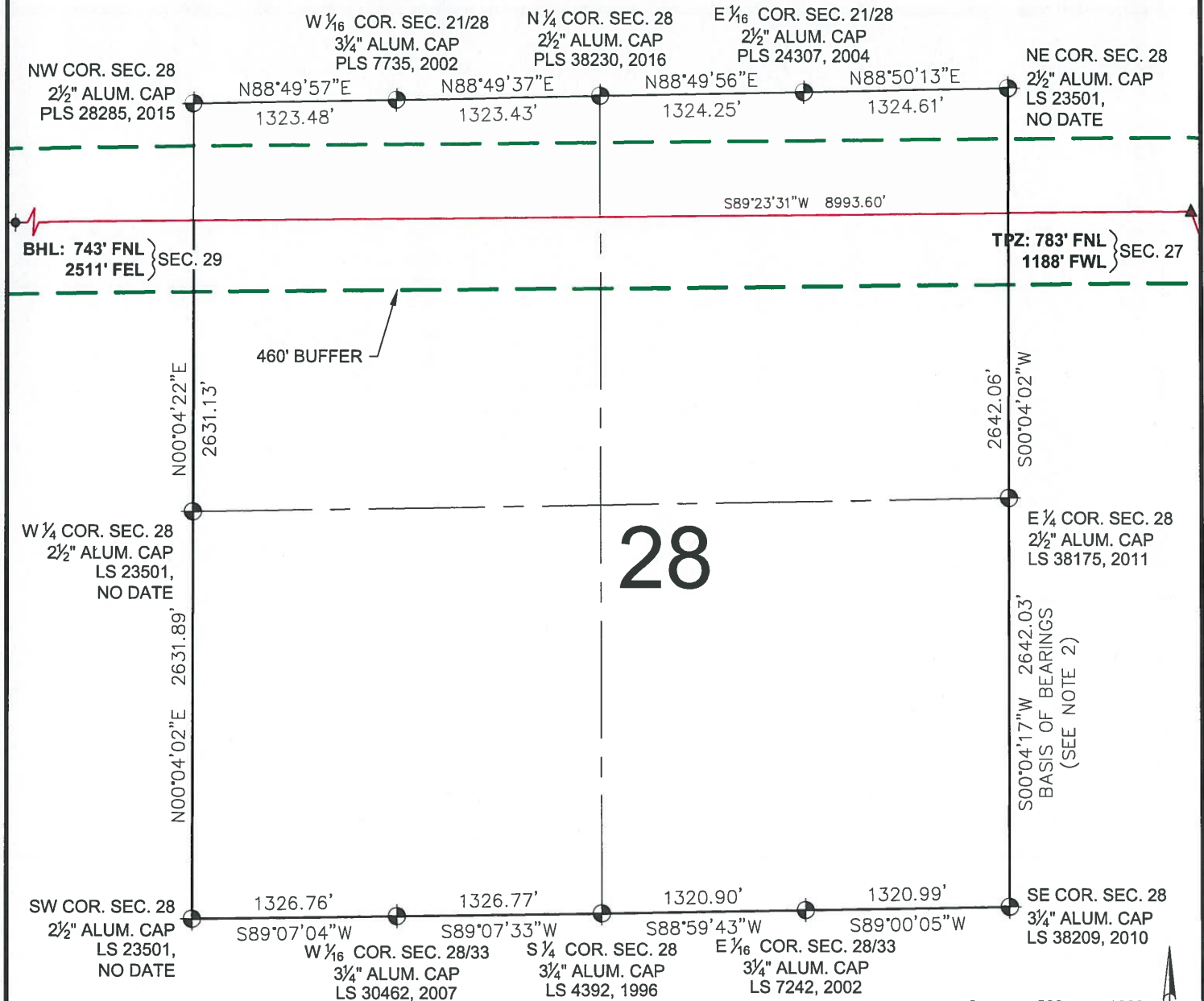

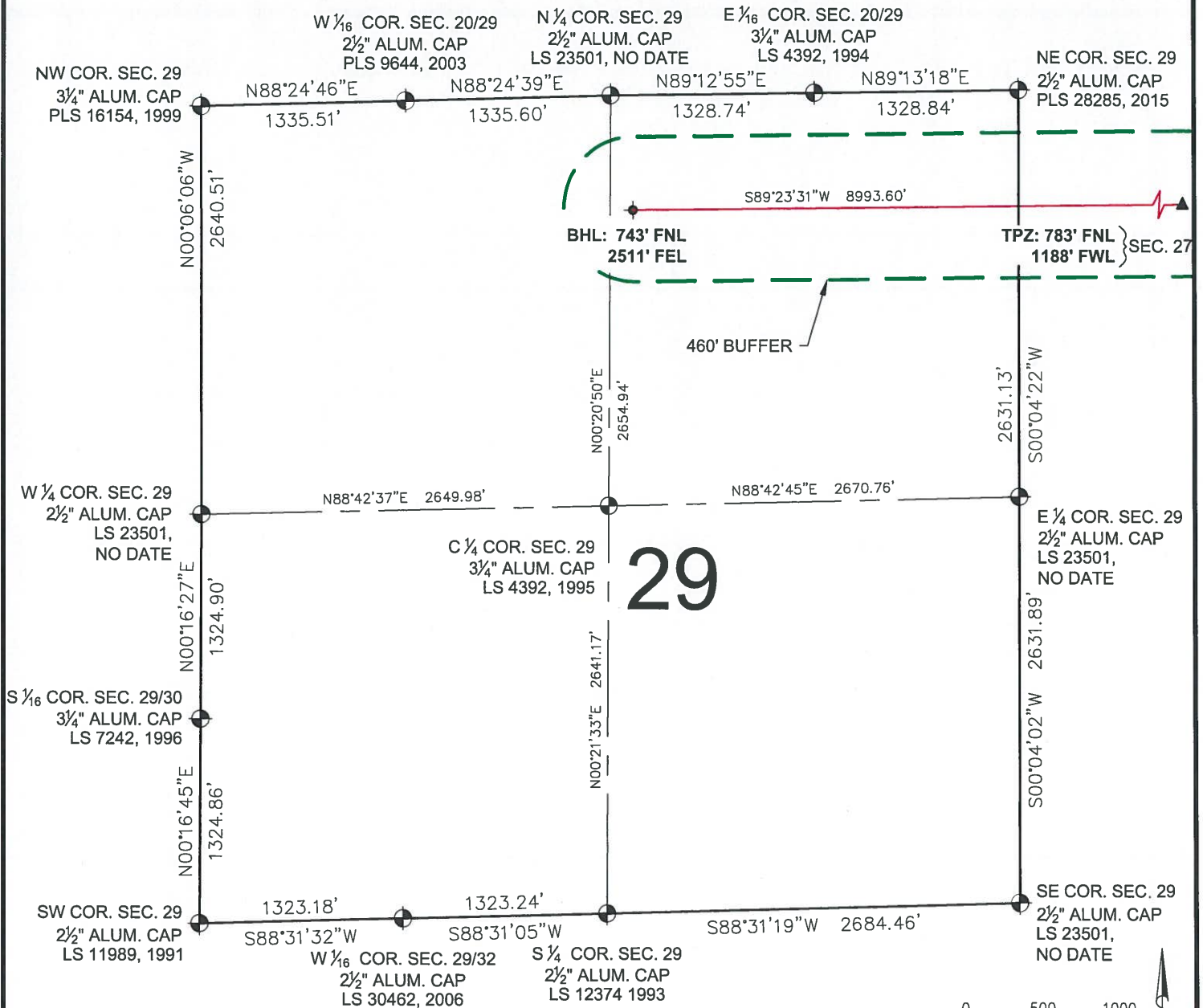
