Due to anti-collision needs and the variability of directional drilling, our as-drilled BHL could be different than the permitted. Per Rule 317.p Exception, compensated neutron logs were run on this well.

The Top of Productive Zone provided is an estimate based on the landing point at 7779' MD.

As-drilled GPS data was taken after conductor was set.

Completion is estimated for Q1 2018.
