Comment: Historic spill discover during final reclamation. Impacted soil was reported removed and pending offsite disposal following lab analyses. Soil currently loaded on dump truck awaiting disposal. Well P&A and all infrastructure has been removed. Met with reclamation contractor Clark Co. rep Eric onsite. No sign of petroleum impacted soil on location. Pad has been recontoured and disc tilled. Sulphur and bio-soil amendments being applied and straw mulch stockpiled.

Corrective Action: Per F-19 COA submit a Supplemental F-19 with assessment data including Table 910-1 sample analyses including a figure showing sample locations. If all data indicates Table 910-1 compliance submit "request for closure". If not submit F-27 remediation plan.
