Once the PA 23-26 Cuttings Management area has been filled, any additional cuttings will be hauled by truck to the DOE 1-W-26 pad. After drilling operations are completed on the PA 23-26 pad, the cuttings hauled to the DOE 1-W-26 pad will be mixed, tested, and buried into the existing/proposed cut slope on the DOE 1-W-26 pad. The additional disturbance will be approximately 0.23 acres.
