BBC requests to permit the BHL/TD for this well to be 400' FEL of Section 27. The ability to perforate will be physically constrained by the wet shoe sub and float collar which will be located no less than 460' FEL of Section 27. BBC will not perforate or completed the wellbore within the 460' setback area of the spacing unit. Attached is a well location plat which indicates the Bottom of Completed Interval and BHL TD.
