**Operator Comments:**

This sundry is being submitted in order to request authorization to reseed the drill pad and access road with a native seed mixture. Interim reclamation will commence on approximately 11.15.2017. Various methods will be utilized such as placing topsoil over areas to lift to original grade and to match existing contours. Topsoil will be ripped with a motor grader. The concrete around the well heads, if any, will be removed and transported to disposal. The well pad will be graded and leveled to the existing well pad area to ensure proper drainage and any poor material will be discarded. The seeding shall be repeated until a satisfactory stand, as determined by the landowner, is obtained. The first evaluation of growth will be made following completion of the first growing season after seeding. The proposed interim reclamation plan is attached for reference.
