COMMENTS:

GELLC is requesting a variance to delay interim reclamation. We are requesting a 5 year delay and the operational reason for the delay is that GELLC intends to re-frac the #20-12D well so further evaluation and design of hydraulic refracture stimulation treatment and natural gas price increase sufficient to justify the cost of the restimulation treatment is needed. Our planned schedule of operations is as follows: May 2018-Nov 2019: Evaluate production characteristics of the well and market price of natural gas; May 2020-Nov 2020: Conduct production logging operation to determine intervals contributing to gas and water production, determine Mancos shale intervals to be isolated and intervals to be refracture stimulated; May 2021-Nov 2021: Conduct wellbore isolation and refracture stimulation treatment operations; May 2022-Nov 2022: Produce the well and evaluate the refracture stimulation treatment, evaluate for further workover operations. If no further workover operations are required, begin site reclamation.

Surface owners consent to this delay is attached. Per variance regs, GELLC is in compliance with Rules 1002f, 1003a and 1003f, all of which are noted in the inspection report. Also attached is an estimate of what it would cost to complete interim reclamation as well as a signed Tolling Agreement, per the regs of a variance request.
