#### COMMENTS:

Ausco reevaluated drilling fluids/cuttings disposal and changed drilling/waste management plan from using a 30' x 60' lined pit to utilizing two steel, containment tanks for cuttings disposal. The use of these tanks eliminated environmental exposure to drilling fluids and cuttings. Cuttings were removed and taken to Twin-Enviro Services located in Fremont County, CO. Drilling commenced with the conductor hole on 8/02/17 and was finalized on 9/19/17.
