OPERATOR COMMENTS AND SUBMITTAL

Comments

The surface hole footage calls are different by 1' from the original permits due to a different surveyor being used and a difference in mechanical equipment.

The name of this well was changed from the Ivey M-14-23HC (originally permitted by Synergy) to the Ivey 1426-1-10HNC. The landing point and bottom holes have also changed.

Distance from completed portion of the wellbore to nearest wellbore permitted or completed in the same formation was measured to the proposed Ivey 1426-1-11HNB which is being permitted on the same pad.

Distance to nearest permitted or existing wellbore belonging to another operator was measured to the Plugged and Abandoned Ehler 10-14 which was only drilled to the Sussex formation. The distance listed on the Drilling tab does not taken vertical separation into consideration.

1	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
2	Drilling/Completion Operations	Anti-Collision: Ward will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice will be given to all offset operators within 150 feet prior to drilling.
