<p>Inspection doc. #682502392 documented that crop vegetation over the access road is significantly stunted when compared to the adjacent reference area (likely due to compaction concerns). Inspection required operator to perform additional reclamation work on the access road. Sundry doc. #401459517 indicated operator will address concerns from previous corrective actions once crop is harvested. Attached photo document shows corn crop has been harvested. Unable to find evidence that additional reclamation work had been conducted per the corrective actions. Original corrective action and corrective action date remains applicable.</p>
