The tanks were used to facilitate completion operations of a well (Falcon Seaboard 11-90-12 #5) on a lease committed to the federal Bull Mountain Unit. The Hughes 11-90-26 #3 well pad is on a lease that is also committed to the federal Bull Mountain Unit. The Bull Mountain Unit is considered a single lease for production and operational purposes.
