Bison requests the removal of the 05-123-09270, TRUEBLOOD-SKEETERS 1-13 from the Conditions of Approval for offset well mitigation per DJ Basin Horizontal Offset Policy on APD #401338053. The stated offset well is more than 1500' from the proposed wellbore. Bison is not planning to drill and complete a well that falls within 1500' of the stated offset well in the immediate future.

In additiona, Bison also requests the removal of the 05-123-05533, DE FORD 1 from the Conditions of Approval for offset well mitigation per DJ Basin Horizontal Offset Policy on APD #401338053. The stated offset well is more than 1500' from the proposed wellbore. Bison will complete the required mitigation before drilling and completing any well that falls within 1500' of the stated offset well.
