At least one (1) person with training for blowout prevention will be on location during all drilling operations.</p> <p>Confluence will utilize drilling rigs with a minimum of a double ram and annular preventer.</p>

Pressure testing will be conducted and the documented results will be retained by the Confluence for inspection by the Director for a period of one (1) year.
