Extraction respectfully requests an Exception to Rule 318A.a. & Rule A.c. The Ardrey wells are located outside a GWA window and are further than 50' away from an existing well. Extraction is the surface owner and self-waives Rule 318A.a. & Rule A.c.

The surface owner, 7N LLC (An Extraction company), leased the property to Richmark Real Estate Partners. Richmark then entered into a surface use agreement with Extraction. The SUA grants Extraction an irrevocable, exclusive easement to use the surface of the Property to conduct oil and gas operations.
