## OPERATOR COMMENTS AND SUBMITTAL

Comments Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to Ursa's proposed JIMMY GULCH 3G 12C-3-3-97. Distance to the nearest well completed in the same formation / permitted or existing well belonging to another operator was measured at 5270' to the XTO Energy Inc - Freedom Unit #297-33A5 (API 05-103-11295).

This well is being proposed from an existing pad on Fed-owned surface. The proposed well will BHL on federal minerals. Pre-application notifications were not required as all surface owners within 1000' are Federal and there are no building units located within 1000' of the pad location. Ursa will be pursuing Federal APDs for the proposed Jimmy Gulch 3G wells concurrently with this application.
