Form 2A is being submitted for additional wells being planned from this location, however there is no additional surface disturbance proposed at this time. There is currently 1 producing well on this pad (please refer to facilities layout for additional detail).

Pre-application notifications were not required as the surface owner within 1000' is BLM and there are no building units located within 1000' of the pad location. Ursa will be pursuing Federal APDs for the proposed Jimmy Gulch 3G wells concurrently with this application.
