Distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to Ursa's proposed JG 3K 13B-3-3-97. Distance to the nearest well completed in the same formation / permitted or existing well belonging to another operator was measured at 5630' to the XTO Energy Inc's Freedom Unit #297-33A5 (API 05-103-11295).

This well is being proposed from an existing pad on Fed-owned surface. The proposed well will BHL on federal minerals. Pre-application notifications were not required as all surface owners within 1000' is Federal and there are no building units located within 1000' of the pad location. Ursa will be pursuing Federal APDs for the proposed Jimmy Gulch 3K wells concurrently with this application.

The distance to nearest public road is listed at 195'. However the road is not a county road and is secured by a locked gate.
