Operator Comment: The landowner planted a new alfalfa crop, we'll assess growth in the spring, and if stunted, we'll address compaction issues in the Fall of 2018.

COGCC Decision: **Not Approved**

COGCC Representative: Inspection #682502119 dated 6/1/2017 provided operator opportunity to collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities, and to provide a schedule by 6/16/2017. Operator failed to respond to this inspection or submit a form 4.

Follow-up Inspection #675103826 dated 8/14/2017 documented that the crop within the field had been harvested, and the field was currently bare. Operator was then given a corrective action date of 9/15/2017 to perform the required reclamation.

Not approving resolution of corrective action complete. Operator statements indicate no work has been performed per the corrective action. Location will remain out of compliance until corrective action has been addressed.
